

Lee's Hoagie House Sweepstakes
Official Rules
October 1, 2010 – December 7, 2010

PRELIMINARY INFORMATION: NO PURCHASE NECESSARY. A purchase will not improve your chances of winning. The Lee's Giveaway ("Giveaway") will begin on October 1, 2019 at 8:00 am ET and end on December 7, 2019 at 1:00 pm ET ("Giveaway period"). All times in the Giveaway refer to Eastern Time ("ET"). Odds of winning depend upon the number of eligible entries received. Giveaway is subject to all applicable federal, state and local laws.

ELIGIBILITY: Open only to permanent, legal U.S. residents who are eighteen (18) years of age or older and the age of majority in their state as of the start of the Giveaway Period. Officers, directors, and employees of Giveaway (as defined below), members of these persons' immediate families (spouses and/or parents, children, and siblings, and their spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Giveaway. Limit one (1) entry per person/email address per day of the Sweepstakes Period. Multiple entries received from any person or email address beyond this limit will void all such additional entries. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason, including, but not limited to, computer or network malfunction or congestion, are void and will not be accepted. In case of a dispute over the identity of an entrant who made a potentially winning entry, Sponsors reserve the right to deem that the entry was made by the registered subscriber of the email address submitted at the time of entry. Entry constitutes permission (except where prohibited by law) to use entrant's name, city, state, likeness, image, and/or voice for purposes of advertising, promotion, and publicity in any and all media now or hereafter known, throughout the world in perpetuity, without additional compensation, notification, permission, or approval. WINNER SELECTION AND NOTIFICATION: On or about December 7, 2019 after 1:00 pm ET, one (1) potential winner ("Winner") will be selected in a random drawing by representatives of Sponsors from all eligible Entries received during the Giveaway Period. Sponsors will make two (2) attempts to notify potential Winner at the phone number and/or email address submitted at the time of Entry. Potential Winner may be required to execute and return an affidavit of eligibility, release of liability, and, except

where prohibited, publicity release (collectively, "Sweepstakes Documents") within one (1) days of such notification. Noncompliance within this time period may result in disqualification, and, at Sponsor's sole discretion an alternate potential Winner may be selected from the remaining eligible Entries.
